1. The terms of shipment delivery are indicated in business days from the capital to the capital and do not include the day of collection of the shipment. The delivery terms are approximate and cannot be considered as clearly defined and guaranteed, may differ from those indicated in the IEW or on the website and do not include: the day of handover of the IES for transportation; weekends; official holidays; days on which banking institutions are closed; duration (periods) of delays associated with security checks of shipments; terms of customs clearance of shipments; delays caused by circumstances beyond the control of the Contractor.
2. For Norway and Switzerland, a transit declaration is required. The registration fee is EUR 70 and is not included in the tariff.
3. The service is not available for islands.
